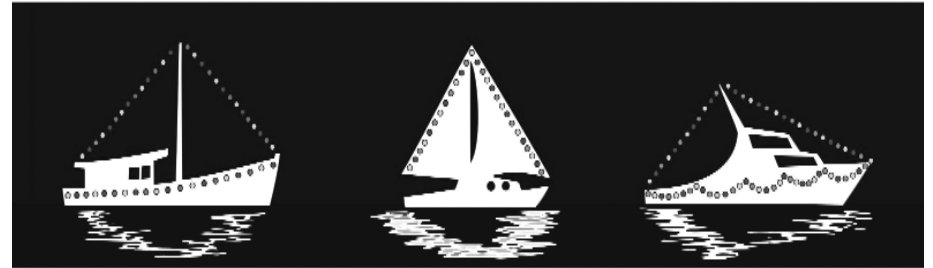

*Application for Arts, Crafts and Food Booths*

**Location**

The 10th Annual Christmas by the River, will be held at the Moss Point Riverfront Park, December 6, 2008. The festival is scheduled from 1 pm until 7 pm. The event is sponsored by MPAC (Moss Point Active Citizens).

**Entry Fee**

The charge for a 10x12 booth is \$50.00. Please make the check payable to: MPAC • P.O. Box 8583 • Moss Point, MS 39562 and clip it to your application. The booth fee is returned if your application is not accepted. An accepted application is a commitment to the festival and no refund will be made for cancellations. No fee will be refunded due to weather. Subletting a booth is not allowed.

**Booth Spaces**

Artists, crafters and food vendors are allowed a 10x12 space. If you need more than a 10x12 then you must purchase a second booth. If you are an art and craft exhibitor, your booth will be located under a 40x80 tent provided by the Christmas by the River Committee. You do not need to bring a tent. The 40x80 will also have heat and flaps if needed due to weather conditions. If you are a food vendor, you will be assigned a space for your booth or trailer on the grass near the waterfront and you will need to provide your own tent.

**Deadline and Selection**

Applications must be postmarked by September 8, 2008. The jury committee for Christmas by the River selects exhibitors deemed best to reflect creativity, quality and originality. We are looking for unique items for Christmas by the River. Selection is made on the basis of two recent photographs representing your work and display. Please print your name on the back of the photo and send a self addressed envelope if you would like your photo returned. Once you have been selected as an exhibitor, additional information will be sent to you.

**Standards**

1. Exhibitors bear the responsibility for all setup and security needs for their exhibits. The Christmas by the River Committee or the City of Moss Point will not be responsible for and loss or damage of any kind.
2. Vendors must provide their own tents, tables, racks, chairs and electrical cords. If you must use an electrical cord, you are responsible to make sure it is safely plugged into an outlet free of pedestrian traffic. Please be prepared for all weather conditions such as rain, wind or cold temperatures.
3. On-site gas powered generators or amplified music prohibited.
4. This is a family-oriented event for people of all ages. Exhibitors must keep within this atmosphere.
5. The sales of drinks are not allowed. Rotary of Moss Point is the only drink vendor. 100% of all money raised by Rotary is put back into the community.
6. Sales Tax of 7% must be collected and turned into the Christmas by the River T-Shirt booth by 7 pm on Saturday.
7. You will be provided reserved parking close to the vendor area.
